International applicants must demonstrate that they have access to sufficient funds to cover the complete cost of their academic and living expenses for at least one academic year. The total amount of **\$27,226** must be guaranteed. Students accompanied by a spouse must add an additional US \$4,000 annually to their expenses. An additional \$3,000 is required for each child. **Note:** The approximate cost of living expenses, tuition, fees, books, and health insurance is \$27,226. This is calculated for the 2010-2011 year, but due to inflation and fluctuations in currency exchange rate, this figure can increase up to 15% per year and for each year thereafter.

A Statement of Financial Support should be completed by each individual/organization/sponsor that will assume a roll in providing funds for the student to attend Mesa State College. If an organization or agency is sponsoring the applicant, the individual representing the organization or agency should sign this form.
