Note: The approximate annual cost of living expenses, tuition, fees, and books is calculated each academic year, but due to inflation and fluctuations in currency exchange rate, this figure can increase up to 15% per year and for each year thereafter.

A Statement of Financial Support should be completed and notarized **by each individual/organization/sponsor** that will assume a roll in providing funds for the student to attend Colorado Mesa University. If an organization or agency is sponsoring the applicant, the individual representing the organization or agency should sign this form. If the student will be sponsoring him/herself, the student must fill out this form in its entirety.
