#### V. INFORMATION ITEMS

- A. Natural Science Essential Learning Requirements, Dr. James Ayers
- Dr. Ayers presented a proposal to amend the university's current stipulation regarding the fulfillment of seven (7) essential learning credit requirements across various programs, using Biological Sciences as illustration. The argument for the proposal cites the current procedure for fulfillment of these seven (7) credits in a <u>reasonable way</u> does not serve the student's scholastic growth because it limits department input on course selection: The proposal suggests that a program's department be able to specify an assortment of courses to satisfy these requirements in order to best serve the student's academic development.

President Collins reminded senators that this presentation is in preparation for future action—probably at Faculty Senate's meeting on April 21<sup>st</sup>.

- B. Statement in Support of HBCUs (Historically Black colleges & universities), Dr. Vince Patarino
- Dr. Patarino proposed a statement representative of CMU's support of HBCUs in response to numerous bombs threats targeting historically Black colleges and universities across the nation.
- A draft statement has been crafted by Patarino. He seeks support from ASG and university upper administration as well as other campus agencies and organizations. The intent is to publicize the statement via CMU Now, the Grand Junction Sentinel and other public forums.

President Collins will bring this issue to the next executive committee meeting and prompted senators to bring any additional ideas to the committee or Dr. Patarino. This issue will be put on a future Faculty Senate agenda

A. Sabbatical Leave Committee Membership

Motion: to charge the Sabbatical Leave Committee with investigating the lack of sabbatical leave on campus

(Kluck/seconded); motion carried.
