- a. Compensation for Internships

  - i. Spoke with the chair of the committee and believes the timeline requested is appropriate and should have a recommendation back to the Faculty Senate by the end of November.

#### VII. New Business

- a. Priorities from the climate survey
  - i. Increased compensation for adjunct faculty
    - 1. Discussion: See below for more information.
  - ii. Additional tuition waiver for dependents
    - 1. Discussion: Eli Hall mentioned that the Faculty Senate created a different ranking of these three priorities. Believe that the tuition waiver for dependents was a higher priority than the increased compensation for adjunct faculty. Increasing funding for tuition waivers for dependents would have a smaller impact on budget. Christopher McKim mentioned that in his department, adjunct faculty pay is a higher priority than dependent tuition waiver and believes that it keeps being pushed back because of the magnitude of the funding it will take.
  - iii. Workload equity studies within department and across campus
    - 1. Discussion: There hasn't been any formal inquiry on workload equity. It is difficult to tackle, as it is tough to determine what is equitable for one individual versus another. Maybe having a review of evaluations would help determine a more standardized view. While Cher reviewed evaluations within each department, to give feedback to Department Heads on where there may be discrepancies or trends to help focus structurally. It is currently being evaluated at an inter-departmental level. Cher met with the committee and gave the charge for what was needed for an updated annual evaluation process/document. Maybe the inequity may be due to not knowing if you are meeting the expectations or level of service and how it is valued.
