

# The Mary Rait/Mary Jewell Willsea Grants

The Mary Rait/Mary Jewell Willsea Grants of \$1,000 per recipient are named in honor of Mary Rait, the first female vice-president at Colorado Mesa University; they have been awarded by the Grand Junction branch of AAUW since 1981. Currently the grants are funded by a generous endowment bequest from Mary Jewell Willsea, the aunt of a longtime member of the Grand Junction AAUW branch.

Competition for the grants is open to non-traditional women students at CMU: that is, students who have begun college at the age of 25 or over, or who have returned to college after a considerable time spent outside the educational establishment. Applicants must be enrolled in a baccalaureate degree program, and may not already hold a bachelor's degree; all majors are welcome to apply. Applicants must have completed 60 hours of college credit (including transfer credit) by the end of the semester in which they apply, with a cumulative GPA of 3.0 or higher. GPA, financial need, and the quality of the applications are all considered by the awards committee, which is made up of members of the Grand Junction branch of AAUW. Awards will be applied directly to the winners' tuition and fees at Colorado Mesa University.

Application forms and deadline information are available from the Colorado Mesa University Financial Aid Office. Grant recipients are selected each year by a committee made up of members of AAUW, Grand Junction branch.
