- Student must meet the scademic residency requirement of a minimum of 15 of the final 30 credit hours must be taken from CMU/CMU Tech.
- . Student must apply within five (5) years after their termination of student status with TCR.
- · Student must have successfully completed the requirements for the above-named program.

STUDENT APPLICATION PROCESS:

STEP 1: Student must envol! at CMU Tech or Colorado Mesa University (CMU) and complete 17 credit hours within essential learning (general education) and lower division courses. Student may need to contact CMU Tech Student Services upon enrollment to ensure that college coursework does not duplicate articulated credit.

STEP 2: Students should obtain a copy of the <u>ARTICULATION AGREEMENT COURSE</u> EQUIVALENCY document from CTE Teacher.

STEP 3: Student should obtain official transcripts from TCR showing attainment of their Technical Certificate, Veterinary Assistant.

STEP 4: Upon completion of the 17 essential learning credit hours at CMU Tech or CMU, student must contact CMU Tech Student Services at <u>TechSS@coloradomesa.cdu</u> and submit documentation identified in step 3.

STEP 5: CMU Tech Student Services staff will review the documents submitted to determine whether they meet the terms and conditions of the CMU Tech/TCR articulation agreement. The Registrar will enter the transferrable credit hours on the student's CMU transcript.
