## Background and Purpose of this Memorandum of Understanding

The Social and Behavioral Sciences Department (SBSD), at Colorado Mesa University (CMU) and the Colorado Department of Human Services (CDHS) with the Office of Behavioral Health (OBH) have recognized the breadth and depth of courses and training needed to prepare students to enter into the addictions field with a high level of proficiency.

The SBSD at CMU has established an Addictions Degree Accreditation Program (ADAP) with a Minor in Addiction Studies (MAS) which offers students education that exceeds the OBH training and education requirements for certification/licensure as an addiction counselor in the State of Colorado.

The OBH verifies that the CMU courses identified below satisfy the addiction counselor training standards established by the OBH through course content, hours of in-class study, additional homework, projects, research and/or papers. Additional requirements for certification/licensure for addictions counseling in CO beyond coursework include clinically supervised work experience hours and taking and passing a national exam. The OBH does not endorse CMU's Addiction Degree Accreditation Program and completion of the MAS does not replace the state requirements in certification/licensure for CAC I, CAC II, CACIII or LAC.
