MBA 3+2 Concurrent Enrollment Program Admission Requirements

This selective program combines an approved undergraduate program with the MBA program, allowing the student to graduate with both degrees in five years. Admission is not guaranteed. Applications must be submitted by **March 1st** to be considered for fall admission. Applicants must meet the following criteria:

1. **Accepted into a Four-Year Bachelor's Program**
 - **BS in Accounting, Public Accounting Concentration:** Completed ACCT 322 or currently enrolled; 9 hours of ACCT (ACCT 201, 202, and 321).
 - **BBA – Finance Concentration:** Completed FINA 301 and FINA 320; 17 hours of BBA Foundation Courses
 - **BS in Construction Management:** Completed CONM 340, 361, and 362 or 370; 17 hours of BS Foundation Courses
2. **Senior Status:**
Must have completed 90+ credit hours, including current and future enrolled courses.
3. **GPA Requirement:**
 - At least 3.00 overall GPA
 - At least 3.00 GPA in major courses
4. **Application Submission:**
Complete the 3+2 Concurrent Enrollment Application and submit to Jessa Dearth in the DSB Office (DH 301), or via email at jdearth2@coloradomesa.edu.
5. **Program Completion Plan:**
Submit the MBA planning form (below) demonstrating how you will meet the remaining bachelor's and MBA requirements within two years.
6. **Faculty Recommendation:**
Provide a name for a letter of recommendation from a faculty member in your department. The recommendation will be requested by the MBA office.
7. **Complete the MBA Admission Process.**
8. **Approval/Denial by MBA Admissions Committee** (within 3 weeks of receiving a complete application package).

Program Expectations Post-Admission

1. **Follow the Two-Year Course Sequence:**
Adhere to the recommended MBA course sequence after acceptance.
2. **Report Life Circumstances:**
Notify the DSB Office immediately if life circumstances prevent program completion within the two-year time frame.
3. **Degree Requirements:**
Complete all bachelor's degree and MBA requirements in the same semester.
4. **Graduation Paperwork:**
Submit bachelor's and MBA graduation paperwork to the Registrar's Office before the published deadline. Please refer to the graduation page on the CMU website for more information.
