UCC Discussion: The teach out plan was implemented and all students completed the course work and graduated in spring 2022. Specifically, there was only one student in the last cohort, who graduated in spring 2022.

1651: Surgical Technology AAS Program Modification - Stern | Bickham Approved

UCC Discussion: 1 and 2.) Changing the credit hours for SUTE 200 and SUTEL 212 aligns more consistently with the content being taught. This change also allows the students to more easily transfer their Medical Terminology credits to another degree program or institution. 3.) Changed the semester offered for SUTE 230 to accurately reflect when this course is being taught. 4.) Changed SUTE 240 credit hours from 4 to 3 so it is consistent with SUTE 220 and 230 credit hours. Therefore, contact hours are the same in all SUTE clinical courses. 5 and 6.) The total program credits will be congruent with the semester credit hours offered.

3132: Kinesiology: BA Program Modification - Stern | Gurka Adapted Physical Approved

Education

UCC Discussion: 1.) KINE 250 has not been offered in many years. The degree allows course credits to be earned by completing KINE 250 or KINE 265. The proposed update would not require any course changes since all students currently take KINE 265 meet the degree requirement. 2.) The current senior seminar course (KINE 494) does not provide adequate professional development for students. A newly proposed course (KINE 394) will allow for better preparing students to plan for careers and graduate studies in kinesiology as it includes more relevant content and is offered earlier in the curriculum. 3-4.) Course sequencing under "Suggested Course Plan" has been updated to reflect these changes. Sequencing has also been adjusted to fit individual course changes (adding KINE 301 as a co/prerequisite for KINE 303/303L). 5.) Added required program SLOs which were previously left blank and better aligned institutional SLOs to align with program SLOs. 6.) Edited credit hours for KINE 499 in suggested course plan from 6 to 4 to correct an error. 7.) Corrected the suggested course



plan to show KINE 211 and KINE 251 as an 'or' in second year fall. Added 3 credits of general electives to second year spring to correct the credit total for general electives and to keep the program total at 120.

- 6) Edited credit hours for KINE 499 in suggested course plan from 6 to 4 to correct an error.
- 7) Corrected the suggested course plan to show KINE 211 and KINE 251 as an 'or' in second year fall. Added 3 credits of general electives to second year spring to correct the credit total for general electives and to keep the program total at 120.

3150: Fitness and Health BS Program Modification - Stern | Gurka Approved

UCC Discussion: 1.) KINE 250 has not been offered in many years. The degree previously allowed course credits to be earned by completing KINE 250 or KINE 265. The proposed update to remove KINE 250 would not require any course changes since all students currently take KINE 265 meet the degree requirement. 2-3.) The current senior seminar course (KINE 494) does not provide adequate professional development for students so it is being replaced with a newly proposed course (KINE 394). More than 10% of the content is different AND we are offering it earlier. Content has been added to KINE 394 (mock interviews, researching graduate programs and jobs, asking for letters of recommendation) to enable students to prepare for life after graduation. KINE 494 doesn't include these components, so students haven't learned about these ideas that are fundamental to being successful professionals. Also, many of our students pursue professional programs (physical therapy, occupation therapy, physician associate). These programs require years of intentional planning to gain experiences to make students competitive applicants. This includes volunteering, work, and extracurricular experiences. Our faculty has noticed that many students don't become aware of these necessary "extra" things until they are at the end of their degrees when it's "too late." Therefore, having KINE 394 earlier in the curriculum will increase awareness of these activities that students should be doing throughout college. Additionally, some programs (like physical therapy, PT) have application cycles that open in the summer. Therefore, a student needs to begin their application for PT school a year before graduating. This means a student must be eligible for PT programs with only three years of college completed. Eliminating KINE 494 and replacing it with KINE 394 will allow students the opportunity to learn more relevant content and to get this important professional content earlier in their program. 4.) The option of "KINE 403 or KINE 404" was added to Fourth Year Spring Semester in the Suggested Course Plan. This has been a degree requirement but had been erroneously left out of the Suggested Course Plan.

- 4) The option of "KINE 403 or KINE 404" was added to Fourth Year Spring Semester in the Suggested Course Plan.

Methods and Specialized Practices in Interpreting. Both FLAS 438 and FLAS 439 are new courses proposed and approved in Spring 2024. The phrase "Select one of the following" and the number of credits required (3) were added for clarification.
- c. The Capstone Experience section was added so that the requirements in Hispanic Studies (BA) match the requirements in Translation and Interpreting (BA). FLAS 498. Spanish Senior Practicum was moved into the Capstone Experience category so that all three Spanish BA programs have the same Core. FLAS 499. Internship was added as an option in this category. The phrase "Select one of the following" and the number of credits required (3) were added for clarification.
- d. The Restricted Elective section was moved from the bottom of the Program-Specific Requirements into the table of courses so that the total semester hours were calculated accurately.
- 6.) In order to match the Translation and Interpreting Track, the note regarding topic courses being taken more than once was clarified and moved into the General Electives section.

3248: Spanish: Secondary BA Program Modification - Stern | Bickham Approved

UCC Discussion: Spanish Program Changes:

- 1. Learning Outcomes, Courses, and Assessment were updated because the information was previously missing (did not transfer when CIM was implemented).
- 2. The Curriculum map was updated because the information was not complete.
- 3. Note on proficiency waiver added in the Foundation Courses section. This information was not in the old program sheets and the waiver was not clear to students. This note will help make the waiver more clear to students.
- 4. In the Foundation Courses section, we eliminated the comment on the combination of course options for other programs requiring a foreign language. It does not pertain to any of the current course offerings for the Spanish BA.



- 5. Changes to Program-Specific Courses were made:
- a. FLAV 496 was removed from the text at the top of the Program Specific Requirements because FLAV 496 is not an applicable class for students in this program. In this section, FLAS 422 was corrected to FLAS 424 this was an error from a past edit.
- b. The formatting for the option between FLAS 424 Advanced Hispanic Literature and FLAS 446 Spanish Language Variation was changed from and 'or' to 'select one of the following' to match the format of the other subheadings.
- c. Under the category Applied Studies, the following Translation and Interpreting courses were updated (number and title) to match the current catalog: FLAS 434. Introduction to Translation was replaced with FLAS 438. Methods and Specialized Practices in Translation. FLAS 435. Introduction to Interpreting was replaced by FLAS 439. Methods and Specialized Practices in Interpreting. Both FLAS 438 and FLAS 439 are new courses proposed and approved in Spring 2024. The phrase "Select one of the following" and the number of credits required (3) were added for clarification.
- d. The Capstone Experience section was added so that the requirements in Hispanic Studies (BA) match the requirements in Translation and Interpreting (BA). FLAS 498. Spanish Senior Practicum was moved into the Capstone Experience category so that all three Spanish BA programs have the same Core.
- e. The Restricted Elective section was added to the bottom of the Program-Specific Requirements so that the total semester hours were calculated accurately.
- 6. In order to match the Translation and Interpreting Track, the note regarding topic courses being taken more than once was clarified and moved into the General Electives section. Education Program Changes:
- 1. X97 is a reserved course number for practicum courses. EDUC 497 and EDUC 497E are lecture courses and have been for at least the past 17 years.
- 2. The course proposals of EDUC 480 and EDUC 480E will replace these two courses and bring the course number in alignment with university curriculum policy and more accurately establish the course as a lecture course.
- 3. When CMU added Critical Thinking as an institutional outcome, we agreed to connect it to the assessment outcome in teacher education. However, we never formally made the change to the program sheet.

- c. Under the category Applied Studies, the following Translation and Interpreting courses were updated (number and title) to match the current catalog: FLAS 434. Introduction to Translation was replaced with FLAS 438. Methods and Specialized Practices in Translation. FLAS 435. Introduction to Interpreting was replaced by FLAS 439. Methods and Specialized Practices in Interpreting. The phrase "Select one of the following" and the number of credits required (3) were added for clarification.
- d. The Capstone Experience section was added so that the requirements in Spanish Secondary Education matches the requirements in Translation and Interpreting (BA). FLAS 498 Spanish Senior Practicum was moved into the Capstone Experience category.
- e. The Restricted Elective section was added to the bottom of the Program-Specific Requirements.
- 6. The note regarding topic courses being taken more than once was clarified and moved from the top of the Program Specific Requirements section into the top of the General Electives section. The previous text was "FLAV 496, FLAS 422, FLAS 424 may be taken more than once as long as the title/content of each course differs. Permission may be required to take Topics courses. Check with the professor" and the new text is "6 semester hours. FLAS 424 and topics courses may be taken more than once as long as the title/content of each course differs."

Education Program Changes:

- 1. Inactivating EDUC 497 and EDUC 497E.
- 2. Creating EDUC 480 and EDUC 480E to replace these two courses. Updated the suggested course plan accordingly.
- 3. Add "Critical Thinking" to Program Outcome #10.

3253: Music: Liberal Arts BA Program Modification - Stern | Gurka Approved

UCC Discussion: 1.) Program SLOs were updated to clarify SLO verbiage and accurately reflect how/when assessments are happening in the program. 2.) Piano course sequence: the Department of Music has restructured piano proficiency requirements by reducing levels, adding a preparatory course, and aligning learning objectives for clarity and industry relevance. 3-4.) MUSA 250: Reclassifying Beginning Conducting as a lab course aligns with its emphasis on student practice, observation, and active participation rather than passive learning. The piano literature sequence has been reduced from two semesters of MUSA 302 and 304 to one semester of MUSA 305 Keyboard Literature. 5.) Text was updated to clarify piano proficiency requirements and remove mention of the departmental recital/concert attendance requirements. 6.) Updated General Elective credits from 25 to 23 to balance out the Foundation and Program Specific Requirement credit changes so the program total remains at 120.

- 3. Changed credits in Program Specific requirements from 35 to 34 because of the 1-credit decrease in MUSA 250 Beginning Conducting (course changed from 2 credits to 1 credit).
- 4. Removed MUSA 302 and 304 Keyboard Literature I and II and added the new MUSA 305 Keyboard Literature to Program Specific Requirements.
- 5. Updated text in Program Specific Requirements header to update credit totals and piano proficiency requirements.
- 6. Updated General Elective credits from 25 to 23.

3257: Dance BA Program Modification - Stern | Bickham Approved

UCC Discussion: 1.) The Choreography Practicum course titles were changed to Choreography and Production Practicum to reflect how that course is addressing both choreographic skills and other aspects of dance production. We also needed to update SLO's, descriptions, credit hours, etc in our efforts to update all course offerings in the BA in Dance degree. Last year, we implemented a new two credit course called Dance Company and Production, however, it became clear that this type of course does not align well with our ongoing programmatic shifts around our production season. Making some modifications to the DANC 290, DANC 390, and DANC 490 more adequately serves our students and is a better fit with our production season in relation to the larger departmental events in Theatre Arts. Having it as a one credit course also creates more opportunities for students to practice various skills. We are still able to address the skills of Dance Company and Production DANC 140/240/340/440, but in a more accessible way. This is why we will be removing DANC 140/240/340/440 from our curriculum at this time. 2-3.) We are putting DANC 250 back into the BA in Dance. It was originally taken out because we proposed a new course DANC 260 in the hopes that course could address two areas of content. However, after offering DANC 260 in 2024, it became apparent that this was not possible and we need to have the two areas of content (Movement Analysis and Improvisation) addressed in two separate courses. We also felt that shifting the Movement Analysis content to later in the academic plan would better serve our students. That is why we are proposing the new course DANC 360 Movement Analysis and Creative Practice. Theatre Arts faculty have also expressed an interest in having an upper division option for students who are seeking degrees in Theatre. 4.) Courses were shuffled in suggested course plan to to accurately reflect the program requirements and better balance coursework for students. 5.) The requirement for additional hours of upper-division coursework in General Electives changed from 12 to 10 due to the addition of DANC 360.

Change Item Description

List all proposed changes to the program:

- 1. Removing Dance Company and Production courses (DANC 140, 240, 340, 440) from the curriculum and replacing with Choreography and Production Practicum courses (DANC 290, 390, 490).
- 2. Removing DANC 260 and adding DANC 250 back in the curriculum as a Foundation Course, Foundation credit total



decreased from 12 to 11.

- 3. Adding new upper-division course DANC 360 (that replaces DANC 260) in Program Requirements and SLO map, Program Requirements total changed from 42 to 43 credits.
- 4. The Suggested Course Plan was edited to accommodate the removal of the Dance Company and Production courses and add the Choreography Practice and Production courses. The plan was also adjusted to remove DANC 260 from 2nd year spring and add DANC 250 to 2nd year fall, DANC 220 was moved from 2nd year fall to 1st year fall, and DANC 355 was moved from 3rd year spring to 3rd year fall. DANC 360 as added to 3rd year spring. The dance technique courses and general electives were adjusted to accurately reflect the program requirements.
- 5. The General Electives credit total remained unchanged, but the requirement for additional hours of upper-division coursework changed from 12 to 10.

3264: Theatre Arts BA Program (General) Approve

Program Modification - Stern | Bickham Approved

UCC Discussion: Previously all practice courses had separate numbered courses for each semester. In order to streamline registration, practice courses have been reduced to one to two per year and made repeatable. For example, a freshman will now take THEA 220 twice instead of THEA 219 and THEA 220. This change reduces the number of THEA courses on the books, making it easier for students to register.

- 1. Remove THEA 347 and THEA 447 Drama Performance from Program Specific Requirements (under practice options). THEA 348 and THEA 448 will remain and are repeatable.
- 2. Remove THEA 317, THEA 318, and THEA 417 Play Production from Program Specific Requirements (under practice options). THEA 218 and THEA 418 will remain and are repeatable.
- 3. Remove THEA 319, THEA 320, and THEA 419 Technical Performance from Program Specific Requirements (under practice options). THEA 420 remains and is repeatable.
- 4. Removed THEA 347, THEA 447, THEA 319, THEA 320, and THEA 419 from the SLO table since these courses have been inactivated.
- 5. Program Overview edited slightly for readability.
- 6. Increased Upper Division Restricted Electives from 9 to 11 credits on Program Specific Courses and Course Sequence to provide students more upper division choices in the major.
- 7. Increased program specific credits from 44 to 46 credits due to increase in Restricted Electives.
- 8. Reduced General Electives by 2 credits on General Electives and Course Sequence to keep program at 120 hours. Overall program hours did not changes.

- 4. Removed THEA 347, THEA 447, THEA 319, THEA 320, and THEA 419 from the SLO table.
- 5. Program Overview edited slightly for readability.
- 6. Increased Upper Division Restricted Electives from 9 to 11 credits on Program Specific Courses and Course Sequence.
- 7. Increased program specific credits from 44 to 46 credits.
- 8. Reduced General Electives by two credits on General Electives and Course Sequence. Overall program hours did not change and remain at 120.

3265: Theatre Arts: BFA Program Modification - Stern | Bickham Approved

UCC Discussion: 1.) Removed THEA 117, THEA 118, THEA 147 and THEA 148 since they were inactivated. UCC Discussion: 1.) POLS 472 has not been taught in at least 10 years due to lack of capacity to teach the course. It is not expected that the political science program will have the capacity to teach this course in the foreseeable future. POLS 472 is currently listed as a political science elective. Students still have a considerable number of electives to choose from, including several that have an international relations aspect. Since POLS 472 will not appear in the 2025 catalog, it needs to be removed from the list of political science electives. 2.) POLS 335: Political Campaigns has been taught 3 times as a topics class. The feedback from students is that they see the course as highly relevant and it will now be offered as an option for Experiential Learning and as an elective. 3.) INTS 101 is being removed because the course is no longer offered. This course was designed as the anchor course for the International Studies minor, but because of consistent low enrollment, INTS is being inactivated (and students in the minor can choose between POLS 270 and GEOG 103 - POLS 270 is already required in this program so there's no need to replace INTS 101 with anything). 4.) UCC Discussion: 1.) We are clarifying the clause to our policy requiring students to pass their courses with a C or better to ensure students are prepared as they move from preregs to the subsequent coursework. This has always been a requirement and was previously stated in the Program Overview, and is now in two more places (Institutional Requirements and Program Specific Requirements) to increase visibility to students. 2.) OREC 105 (formerly a KINA Backpacking course) was a listed choice in our program before the OREC program was created. OREC now requires the backpacking course to be taken concurrently with OREC 104 (Orienteering). The AAG program is being changed to reflect this co-requisite. As part of this change we are removing KINA 112 (Hiking) as a listed choice and requiring both OREC 104 and 105. 3.&5.) We are still the only four-year institution in the state that does not currently offer a standalone Cultural Anthropology class. Re-adding the course would bring us into alignment with other BA-granting institutions across the state and country. 4.&5.) Not all students in our major seek advanced training in archaeology. Some join us for forensics or geography alone. Still others seek only to focus on more ethnographic coursework. By removing ANTH 420/L from the core courses we will no longer be 'forcing' all of our students to do archaeological fieldwork. It will still be an option for those who want to try it, and the course will still be required of archaeology minors, but these five hours (that come with a steep-ish course fee) should not necessarily be foisted upon those students that have no desire to pick up a trowel. Making this an option in the Applied Anthropology and Geography Electives for students who wish to do archaeology further brings us in

The MUSA 410 credit reduction was done to accommodate the new instructional type. 3.) MUSA 210 is a new course that fills a gap for vocal pedagogy that existed in our course offerings. 4.) Expanding MUSL courses to upper-division levels provides consistent, level-appropriate skill-building and performance opportunities and allows the program to better balance lower- and upper-division requirements. 5.) Program Specific Requirements credit total changed from 24 to 23 because of the decrease in credits for MUSA 130. The credits for this course changed from 2 to 1 because the instructional type changed from lecture to lab: academic/clinical. One credit of lab provides enough engagement minutes to cover the course material.

UCC Discussion: 1.) We removed DANC 260 as we are changing this course to a 300-level course in our BA in Dance degree and adding DANC 250 back into the curriculum. We created DANC 260 in the BA in Dance revision in the hopes that it would adequately address two areas of content. Unfortunately, after offering it in 2024, it became clear that there is not enough time to effectively address both areas of content. We want to bring DANC 250 back into the curriculum as its own separate course in Dance Improvisation. And then we proposed a new course DANC 360 to address Movement Analysis and Creative practice in a more robust way. This is offered as an option for students to choose as part of their theory courses. 2.) They can now choose between DANC 315 or DANC 360 as per their unique interests offering more flexibility in the dance minor. 3 & 5.) We proposed DANC 140/240/340/440 last year as a new course. Unfortunately, after offering this course in 2024, it became apparent that this two credit course does not align well with larger programmatic functions and departmental production season so we are removing them. The total credits for the minor have been subsequently adjusted. 4.) We are adding back in DANC 290/390/490 as an option for students to practice choreographic and production skills. This one credit option offers more accessibility and flexibility within the minor and more effectively addresses the educational needs of dance minor students. It also aligns with our current offerings in the BA in Dance degree.

UCC Discussion: 1.) Changes were made to the Spanish (MNR) to match the information provided by the Registrar's Office and avoid confusion among students. 2.) Between the available upper-division FLAS and FLAV courses there are single-credit and variable-credit, so a student could technically complete 6-7 courses and have less than the total hours needed. Specifying the total number of necessary credits reduces this ambiguity.

M270: Theatre MNR Program Modification - Stern | Bickham Approved

UCC Discussion: Previously all practice courses had separate numbered courses for each semester. In order to streamline registration, practice courses have been reduced to one to two per year and made repeatable. For example, a freshman will now take THEA 220 twice instead of THEA 219 and THEA 220. This change reduces the number of THEA courses on the books, making it easier for students to register. In the Program-Specific Requirements, students still have 21 courses to choose from and must select nine credit hours. In the list of upper-division courses, students must choose six hours from a list of over 30 course selections, so the inactivation/removal of these courses doesn't limit the students.

M420: Geology MNR Program Modification - Stern | Driskell Approved

UCC Discussion: The addition of these three courses offers students seeking this minor an opportunity to tailor their education in areas specific to their interests and career trajectories.



GEOL 465: Climate-change science builds a foundation for understanding (1) what climate change is, (2) the rate at which it is happening, relative to past changes in Earth's climate, and (3) how science-based solutions and mitigation can make a meaningful impact in today's world. Educating this generation and future generations about the science-based causes and effects of global climate change is important, because implementing solutions and/or policy depends on informed citizens with science-based critical thinking skills. Lastly, most universities in the USA offer a climate-change science course.

GEOL 463 Subsurface Methods. The course of subsurface methods is a fundamental course for understanding (1) what tools geoscientists use to characterize the subsurface, (2) the stratigraphic and structural characterization of sedimentary strata distributed in the subsurface, and (3) how to use these characterization techniques to map, predict and populate petrophysical properties and lithological distributions for different depositional environments. Educating this generation and future generations about how to map and characterize rocks in the subsurface is fundamental to optimizing the extraction of natural resources such as water or hydrocarbons to contribute to the development of society. Additionally, most universities in the USA offer courses training students on tools and techniques for subsurface mapping since it is fundamental to developing and exploring natural resources. CMU would benefit from offering these courses to our student body.

Drone-related courses typically revolve around the mechanics of drones, the particulars of software, and basic data acquisition. This course is designed to instead focus on allowing students to stay up to date with the applications of drone-related data in their field. Specifically, this course-based undergraduate research experience (CURE) will culminate with students giving oral presentations and written reports on a semester-long Earth-science project of their choosing. As a result, students will not only understand the specific details of hardware & software, but will also be able to use quantitative analysis of drone data through acquisition planning, data analysis, and data interpretation for hypothesis testing.

M451: Cybersecurity MNR Program Modification - Stern | Bickham Approved

UCC Discussion: CISB 221 Introduction to Digital Forensics is being inactivated and replaced with CISB 301 Digital Forensics thus the reason for the change to Cybersecurity Minor.

Many universities in Colorado offer digital forensics courses at the 300-level or higher, further supporting the justification for this change:

- i. Metropolitan State University of Denver offers a 300-level course titled CIS 3680: Digital Forensics as part of their Computer Information Systems (CIS) program.
- ii. University of Colorado Denver includes CRJU 3320: Digital Forensics in their Criminal Justice program.
- iii. Colorado Technical University, based in Colorado Springs, offers digital forensics coursework that typically falls within the 300-level range, particularly in their cybercrime or information technology-related programs.

Renumbering CISB 221 to CISB 301 will thus aid in the course transfer process between state institutions.

The change enhances the academic rigor of the course and makes the certificate program more appealing to students looking for advanced studies in cybersecurity, and upper division elective credits.

M721: Public History MNR Program Modification - Stern | Bickham Approved

UCC Discussion: 1.) HIST 101, HIST 102, HIST 131, and HIST 132 were removed from the Program Specific Requirements to allow more room in the minor for courses beyond the introductory history courses. This also helps keep the minor as an option for students who may not be history majors but want to go into non-profit management. 2.) Added HIST 407 and HIST 494 as required core courses to provide a solid foundation for this minor, 3.) Added two different restricted elective requirements – 6 hours of ANTH/ARTE/ARTH and 3 hours of ENGL/MASS. The minor is currently a sparse program that only includes history courses, though the history faculty would like to expand the program to include an ala carte selection of courses where students would select from three categories: art history and curation; museum education, communication, and public relations; and museum studies. In addition to diversifying the program, these changes make the program far more interdisciplinary and will bring additional students into associated disciplines, including art history, mass communication, and English, in addition to serving our program. 4.) Increased hours from 21 to 22 to accommodate the addition of the 1-credit HIST 494 course. Note: The History program at Colorado Mesa University currently offers two bachelor's degrees in history and history with a concentration in Secondary Education. The program also offers two minor programs in history and public history. Following the history program review in 2017, the program's faculty began to consider ways to address the external reviewer's recommendation to expanding offerings in public history due to the growing appeal of students seeking to enter careers that offer an applied experience in museum and non-profit management; museum curation and art history; museum education and curriculum development; and archival and collections management. The changes to this Public History minor are the first step in expanding offerings in Public History at CMU.

Giving student's a choice between two "core" courses that are both regularly offered every semester and do not suffer from low enrollment may also have the effect of increasing enrollment in the minor overall. This proposal solves the problem of having to offer INTS 101 at least once a year to cover the few minors.

As such, under the Social and Behavioral Sciences category of the minor, the program sheet should indicate that if a student takes one of these courses as the "core" option (replacing INTS 101) it cannot double count as the core AND one of the courses in



Social and Behavioral Science options. However, a student can take either POLS 270 or GEOG 103 as the core and the other as the Social and Behavioral Science credit.

2) POLS 472 and INTS 101 are being removed as options in the Social and Behavioral category since those courses are being deactivated.

UCC Discussion: 1) We are proposing changing the name back to just Choreography so that it is not confused with the new course DANC 360 Movement Analysis and Creative Practice. As our BA in Dance curriculum was implemented in 2023, we are continuing to make refinements based on assessment of the curriculum and academic plan. 2) The prereq was changed from DANCE 260 to DANC 250. DANC 260 was basically shifted to DANC 360 because Movement Analysis and Improvisation needed to be separate courses. So we are proposing adding DANC 250 back into the curriculum and shifting DANC 260 to an upper division course with some modifications in content. So, basically DANC 260 is no longer going to be offered. DANC 250 is an improvisation course which is the first course in the creative practice part of the dance degree. First, doing so will allow a deeper exploration of methodology available in R, such as more complex simulations, the introduction of bootstrapping, and a potential for discussion of more advanced topics, such as Bayesian statistics (which are heavily computational in nature). Also, statistical methods using Excel are well covered in other courses, such as CISB 341, and Excel is not a primary tool used by practicing statisticians, so its inclusion in this course is unnecessary. Changes to the course description, topical course outline, and SLOs reflect the explanation above and are meant to clarify the topics covered in this course as it has been taught.
