E. 48 hours in major Curriculum Manual Policy:

"D. Majors in Bachelor Programs 1. Guidelines for traditional majors: a. Each student must complete at least 36 semester credit hours in a primary discipline and a maximum of 60 semester credit hours with support courses, except as noted above for PTO Programs b. Majors consisting of more than 48 semester credit hours in the primary discipline are permitted only when it can be documented that such programs are consistent with professional accreditation and/or licensure, except as noted above for PTO Programs. c. At least fifty percent of the credit hours required for the primary discipline shall be in courses numbered 300 and above."
