UCC Discussion: 1.) As per Colorado State Board of Nursing clinical hours were changed from 350 for a LPN to 400 hours, thus our program needs to be able to accommodate this requirement for state licensure. Thus 1 credit was added to NURS106L from 2 to 3 credits. 2.) According to the Curriculum Policies and Procedures Manual, the Foundation Courses category applies only to bachelor's programs and should not be used for Technical Certificate Programs. All program-specific requirements should instead be listed within the Program-Specific Courses category. 3.) The change to 59 matches the number of required credits. 4.) Matches the application deadline for program admission.

Department Justification

- 1. NURS 106L increased 1 credit hour, from 2 credits to 3 credits.
- 2. Program-specific requirements (BIOL 209/BIOL209L, BIOL 210/BIOL 210L, BIOL 241) were moved from the Foundation Courses section to the Program-Specific section under the "Program Pre-requisite Courses" to comply with the Curriculum Policies and Procedures Manual. Credit hours listed under program specific requirements section were increased from 31 to 44 based on the addition of BIOL 209/BIOL 209L, BIOL 210/BIOL 210L, BIOL 241 to this section.
- 3. In the Institutional Degree Requirements: Specific to this program section, increased hours from 58 to 59.
- 4. Essential Learning Requirements footnote 1; updated application deadline from March 1 to Feb 1.

1661: Respiratory Therapy AAS Program Modification - Driskell | Battauz Approved

UCC Discussion: 1.) The RT program proposes changing its prerequisite from CHEM 131/CHEM 131L to CHEM 111. Upon further review, CHEM 111 meets the content requirements needed to maintain accreditation through the Commission on Accreditation for Respiratory Care (CoARC). CoARC has been notified of this proposed change and does not require any additional action from the program to move forward. This adjustment will both satisfy accreditation standards and simplify prerequisite completion, as CHEM 111 is a standalone course, whereas CHEM 131/CHEM 131L requires either successful completion of CHEM 111 or passing an entrance exam. 2.) & 3.) The total semester hours listed under Institutional Degree Requirements and Program-Specific Requirements were updated to reflect the prerequisite change. 4.) The Suggested Course Plan has been revised to incorporate the updated prerequisite.

- 3.) Adjusted the total semester hours form 54 to 52 under Program Specific Requirements section based on removal of CHEM 131/CHEM 131L (5 credit hours) and addition of CHEM 111 (3 credit hours) to this section.

UCC Discussion: This degree concentration has maintained low enrollment for more than 5 years. The number of majors range from 9-15 students per year from 2019 to 2024. After this academic year, the tenured faculty member overseeing this degree concentration will be retiring. This departure leaves the department without a permanent faculty member with adapted PE expertise. Changes in credential requirements are moving towards the requirement of a master's degree to work as an adapted PE teacher. Our Adapted PE degree doesn't align with these standards. All major courses in the Adapted PE concentration are included in other kinesiology degrees. This ensures that current Adapted PE students will be able to complete their degrees.

UCC Discussion: 1.) Exercise Science majors often complete their internship (KINE 499) in healthcare and fitness settings to gain valuable professional exposure and experience. For other students, KINE 487 provides similar value by allowing them to develop hands-on technical skills through the execution of a research study. This update will provide seniors with more choice, enabling them to be better prepared for their selected career path. 2.) SLO 6 was updated in our Departmental Assessment Plans beginning in AY 2020-2021. Updating this SLO aligns with our program standards.

includes removing courses KINE 301 and KINE 415 from SLO #6 and adding KINE 405 in their place and changing the Assessment of SLO #6 to Ethics case study assignment.

: Geography MNR Program Addition - McQuade | Roberson Approved

UCC Discussion: The core justification for this program is to help students position themselves in a globally competitive market. By developing the minor and adding coursework in geography that allows students to demonstrate geographic training, students will have a greater array of employment opportunities available to them. Students across an array of backgrounds—in particular non-traditional students like American Vets with experience using GIS in the field and a background in international deployment—are interested in capitalizing on those experiences and the transferrable skills they acquired therein. A program in geography would allow them to do that—allowing them to bring their knowledge and skills from their geopolitical training and use of technology in these applied settings, build on it and find work where those experiences are valued and transferable. However, it is not solely



this population, many students interested in geography and GIS have expressed interest in potentially adding the minor to position them for advancement in their careers in Search and Rescue, Wildfire fighting, and Surveying. Marking the minor in geography on their transcripts would help articulate their additional skills.

ENGR 140: Fundamentals 3 Course Modification - Gollob | Driskell Approved

UCC Discussion: 1) Changing prereq from "MATH 119; or MATH 119A and MATH 119B" to "MATH 135 or MATH 151 (may be taken concurrently)". This change will ensure that students who take the ALEKS math placement exam and place into Calculus I aren't flagged as 'not meeting prereqs' because they don't have the pre-calc class(es) done. If a student places into Calculus I from high-school (or a transfer institution) they don't need to take MATH 119 (or MATH 119A/B) and they should be allowed to register for ENGR 140. This prereq change isn't actually changing anything, it's just clarifying the prereqs in the system so the prereq report shows more accurate information. 2) Changing the title from "First Year Engineering Project" to "Fundamentals of Engineering Projects". A few students who take this class in their second year have expressed concern over the name and the timing of when they take the class. Removing reference to the first year and replacing it with 'fundamentals' still stays true to the course (we're teaching fundamental concepts), but doesn't give the impression that



the course HAS to be taken in the first year. No course content is changing. 3) Student learning outcomes were updated per SLO reviewer process.

GEOG 356: Geographies 3 Course Addition - Gollob | Andrews of Migration Approved

Project

UCC Discussion: Students who enroll in this course will better understand diverse governance approaches to migration from a variety of perspectives. This will be gathered by analysis of a variety of primary and secondary documents. In so doing, this course will encourage media literacy and informed consumers. Students who enrol in this course will compare and analyze different theoretical lenses for explaining migration flows. In so doing, this course will encourage critical thinking. Students who successfully complete this course will be capable of synthesizing and analyzing primary, secondary, and spatial data and communicating with a broad array of audiences. In so doing, this course will prepare students for public speaking and improve analytic writing skills. This course offers students who have been successful in introductory geography courses the chance to grow their spatial analysis skills in an upper division course through a series of assignments that involve individual and group work, conference style presentations and academic writing, and seminar style discussion. This course provides training in geographic thinking related to migration and provides a relevant and timely opportunity to apply the geographic lens to a contemporary social issue. For students who wish to pursue geography in graduate school or for a career, this kind of course provides direct transferrable knowledge about how geographic thinking might transfer to a variety of other topics providing an example for future opportunities.

KINE 394A: Sport 1 Course Addition - Gollob | Driskell Management Junior Approved Seminar

UCC Discussion: The current senior seminar course (KINE 494A) does not provide adequate professional development for students, so it is being replaced with a newly proposed course (KINE 394A). More than 10% of the content is different AND we are offering it earlier. Content has been added to KINE 394A (mock interviews, researching graduate programs and jobs, applying for internships that support long-term professional goals, asking for letters of recommendation) to enable students to prepare for life after graduation. KINE 494A doesn't include these components, so students haven't learned about these ideas that are fundamental to being successful professionals. Securing a position in sport requires years of intentional planning to build a strong resume. This includes volunteering, solid internship placement, work experience, and extracurricular experiences. Our faculty has noticed that many students don't become aware of these necessary "extra" things until they are at



the end of their degrees when it's "too late." Therefore, having KINE 394A earlier in the curriculum will present an opportunity to both increase awareness, and prepare for, these fundamental experiences. This will provide students with more time to gain experience and build connections in the industry before graduation.

NURS 106L: Adult 3 Course Modification - McQuade | Battauz Concepts I Clinical Approved

UCC Discussion: 1.) Changed the course title from Adult Concepts I Laboratory to Adult Concepts I Clinical per the national accreditation for nursing programs (ACEN) site visit for PN program Sep 9-11, 2025. It was recommended that all change the wording from laboratory to clinical, so the courses are clearly defined for clarity when registering for the class. 2.) Colorado State Board of Nursing clinical hour requirements changed from 350 hours to 400 hours for PN certificate programs. We need to increase the credits of the course from 2 credits to 3 credits (an increase of 1 credit hour) to accommodate this requirement. The additional credit will increase total clinical hours by 45, providing students with more hands-on, direct patient care during their first clinical experience and promoting the development of clinical judgment and critical thinking skills. 3.) Contact hours, academic engagement minutes, and student prep minutes were updated to reflect the change in credit hours on the course.
