C. Deadlines for Submission of Proposals

- 1. By Noon three weeks (4 weeks for the UCC) prior to the meeting, curriculum proposals and other agenda items must be received by
 - a. → the Office of Academic Affairs for proposals to be approved by the Undergraduate Curriculum Committee or by the Graduate Curriculum Committee:¶
 - b. the Chair of the WCCC Curriculum Committee for proposals to be approved by the WCCC Curriculum Committee.
 - c. → the chair of the Graduate Curriculum Committee, for proposals to be approved by the Graduate Curriculum Committee. ¶
- 2. Two weeks before submitting as explained in #1. above, proposals to add or modify courses that include requests to include the course in an Essential Learning category must be submitted to the UCC Chair who will forward the proposals to the Essential Learning Subcommittee, which will meet to discuss the proposal and will make its recommendation within a week to the UCC Chair for further consideration by UCC as explained in Section III.L.3.a. ¶
