### I. Old Business

A. Meeting Minutes, 4.10.18

#### II. New Business

A. Introduction of the New Director of Instruction

No additional nominations were offered. Motion carried unanimously to nominate and elect Quesenberry as the new Group B WCCC CC representative and as the committee's vice-chair.

Liff was announced as the committee's second At Large representative, replacing the seat previously held by Gary Chrisco.

## C. Upcoming Proposals

Hoff announced that proposals for the 9.11.18 meeting as well as feedback regarding necessary corrections are available on the R drive (R:\WCCC Curriculum). Anyone who does not have access to this folder needs to email Dodson so she may requests access be granted.

Dodson announced the addition of a WCCC CC toolbox to this folder. In this, members will find tools that will help guide them through the proposal process. Members were asked to send ideas for any additional tools to Dodson so she may prepare and add these.

#### D. Committee Processes

Sundermann discussed the committee submission review process. Once proposals have been prepared, they should be sent to Sirko for first review. After any revisions requested by Sirko have been addressed, revised proposals are then sent to Quesenberry for additional review. Next, once corrections requested by Quesenberry have been addressed, the revised proposals are sent to Bodyfelt and Dodson. Finally, once all requested revisions have been addressed, the proposals go to the full committee for review.
