The committee seeks better representation from all institutions. Representatives from flagship schools generally do not attend CFAC meetings, while those from smaller schools in the state do. There is hope that the new administration, under Jared Polis's leadership, will be more responsive to CFAC. President Hague thanked Senator Parry for his service.
