VII. REPORTS

A. CFAC, Brian Parry

[Handout: Colorado Faculty Advisory Council Meeting Report – 14 September 2018] The handout was distributed and Representative Parry reviewed it with the senators. Acting VP Hass noted that CFAC provides a vital connection between CMU faculty and state issues.

B. Vice President, Josh Butler

Vice President Butler updated the senators on the status of the senate's standing committees. He asked the senators to let their department colleagues know that there are two committee positions still vacant: Essential Learning Committee (for a "Group A" faculty member) and Distinguished Faculty Award Committee. Elections will be held next senate meeting.

C. Student Government, Jeff Vela

ASG Vice President Vela recounted various student government activities:

- Budget hearings
- Met with the Alumni Board and discussed promoting stronger relationship between students and alumni
- Continued reaching out to Department Heads to enrich affiliations between student government and campus departments: suggesting social gatherings such as barbeques, potlucks or even coffee and donuts
- Attended GJ City Council meeting with aim to improve CMU relationship with city—especially interested in the city's promotion of inclusivity; planning Cultural Diversity Board visits to local schools and advocate for diversity, inclusivity and tolerance, citing CMU as a role model

D. Executive Committee, Darin Kamstra

E. Faculty Trustee, Chad Middleton

Faculty Trustee Middleton reviewed the report with the Faculty Senate, with particular attention paid to Item II. (c), his presentation of CMU's new faculty to the board. Middleton requested that senators share the handout with their department colleagues.

F. President, Kristen Hague

President Hague mentioned the email sent out about the first Faculty and Staff Thursday at The Point. Faculty numbers have, as of late, been decreasing at graduation and convocation ceremonies. Hague asked senators to poll their department colleagues about the reason for this trend.

G. Update from Academic Affairs, Tim Pinnow

Pinnow, as Senior Vice President for Strategic Initiatives, shared the handout with senators. He reported that President Foster was amenable to most of the senate's recommendations made last spring, however it is too late to change online tuition rates. Foster maintains that such a change needs a clearly formulated plan and adequate time to implement.
