A. Early Career Distinguished Faculty Award

Discussion:

The addition of the proposed Early Career Distinguished Faculty Award requires changes to the Policy & Procedures Manual for Faculty Senate Standing Committees.

Concerns were raised about the impact of this award on early career faculty that may be counterproductive. It was suggested that staff recognition in lieu of another faculty award. An alternative view expressed was that campus climate survey results indicate that early career encouragement in the form of an award would prove beneficial to junior faculty and that senators should consider the addition of similar recognition for staff.

Currently there are no budget constraints for the proposed Early Career Distinguished Faculty Award.

Senators worked through the proposed changes to the policy & procedures manual making additional edits.
