- a. Nominations for faculty Board of Trustees representative
  - **i.** Casey will compose a description for Faculty Trustees representative and send it to Parry so he can put out the call for nominations. Must be a tenured faculty member to run.

- VI. Continuing Business

a. Preliminary budget for AY 2023-2024 (CFO Michelle Quinn)

- i. Reviewed the presentation that was given to the Board of Trustees. Colorado (relative to the rest of the US) is 49<sup>th</sup> out of 50<sup>th</sup> for higher education funding. Funding in Colorado (funding per Res FTE): CMU is the lowest in funding of all 4-year colleges/universities and only above CCCS, this is one of CMU's perpetual issues with advocating at the state level.
- ii. Reviewed the FY24 Education and General Potential Uses of Revenue: Costs to Continue (funded) equal \$6.3 million and Budget Requests (not yet funded) equals about \$6 million.
- iii. Compensation: use peer institutions and benchmarking purposes (Metro, Fort Lewis, UCCS, CSU-Pueblo, Eastern Oregon, Appalachian State, etc.) CMU is at 80-90% on the median for the staff side. Hope to have this analysis for faculty by May 1<sup>st</sup>. This is the first step making intentional decisions. Hope to have a multi-year plan to take to the Board of Trustees in August.

Discussion: Why does Adams State have nearly 2.25 times more funding than CMU's funding? It is a public policy concern in relationship to how funding is provided to each institution. President Marshall is aware of these policies and is advocating for CMU.

What is the difference between Academic Positions (faculty position requests to hire for FY24) and Exempt Salary (all faculty and administrative staff who are not part of the classified staff system). Clarification that the increases discussed does not include adjunct faculty. Casey made a request to differentiate by discipline on pay equity, not position title.

- b. Vote for academic policies committee member group A
  - i. Mary Jo Stanley: New as of Jan. 2023 coming from CSU, Stanislaus as the former Department Head of the Nursing Program
  - ii. Tevfik Demirciftci: New to the department

 c. Approval of Faculty Salary and Benefits Committee report Motion: to approve the Faculty Salary and Benefits Committee Report provided on March 2, 2023, as amended. (Collins, Seconded McQuade); Motion Carried



# Motion: to accept the amendment to the Internships (X99): to pay \$150/student for 1 or 2 credit hours, then pay \$55/credit/student for those with 3-12 credit hours. Motion Carried

Discussion: Prior to 2017, internship pay was \$55/credit hour per enrollment. Would like to amend compensation to return to the previous rate of pay for internships.
