ANNOUNCEMENTS AND INFORMATION ITEMS

August 28, 2014

Committee members introduced themselves. Chair Chapin welcomed new members Driskell and Hancock.

Chair Chapin announced that the Curriculum Policies and Procedures Manual has had a minor error corrected on pg. 26 A non-working website url has been updated.

The committee approved the 2014-15 Dates and Deadlines schedule. A new deadline has been added this year for proposals for Applied Studies classes to be included in the Essential Learning category.

A formal request has been made to Faculty Senate to add the Chair of the Essential Learning Subcommittee as an ex-officio member of Undergraduate Curriculum Committee.

Chapin will confirm the term expirations for Atkinson and Quinn-Hensley with Faculty Senate.

Proposal forms were revised over the summer. The new forms were approved with the change of adding the individual WCCC departments to the drop down menu.

Department representatives must submit the forms on behalf of the department. Chair Chapin agreed that the WCCC Curriculum Chair can submit them on behalf of WCCC.

The subcommittee review process as outlined in the Policies and Procedures Manual was discussed.

The 2013-14 Combined Curriculum Committee Annual Report was approved.

Holly Teal, Registrar, provided an update on the implementation of Degree Works. There was discussion about adding the Registrar into the pre-submission review process for proposals.

September 25, 2014

Chair Chapin announced that terms for Quinn-Hensley and Atkins will expire in 2016 rather than 2015, to allow for only one third of the committee changing at one time.

Revisions to Table III-2 of the Curriculum Policies and Procedures Manual were approved.

• Physical Education Recreation: minimum base contact hours decreased from 2.0 contact hours per credit hour to 1.5;

minimum academic engagement minutes decreased from 1500 to 1125; and minimum student preparation minutes increased from 750 to 1125.

 Music: Studio: minimum base contact hours decreased from 2.5 contact hours per credit hour to 2.0; minimum academic engagement minutes decreased from 1875 to 1500; and minimum student preparation minutes increased from 375 to 750.

Holly Teal, Registrar, continued the Degree Works Update. There was a discussion of the increased flexibility with data entry and better reporting tools of this software compared to Banner, and how the new capabilities might be used to support the curriculum change process.

October 23, 2014

Chair Chapin welcomed Jeff Grossman, the new library representative, to the committee.

Kurt Haas, Essential Learning Committee Chair, presented background information on the Maverick Milestone course and answered questions. There was discussion regarding the implementation of the course. The process for the Essential Learning Committee to work with the Undergraduate Curriculum Committee in approving individual topics of the Milestone courses is still being developed. It was noted this course is being approved for the spring past the deadline at the request of the Vice President for Academic Affairs.

November 13, 2014

The Important Dates and Deadlines calendar for 2014-15 was revised as follows:

- Deadline to submit proposals to switch Applied Studies to Essential Learning Category was extended from 11/6/14 to 12/18/14.
- Essential Learning Committee minutes due by Noon on same deadline as curriculum proposals to the UCC_Chair email address to be considered at the next meeting.

A revised Program Delete/Deactivate/Reactivate form was approved, as the options for program deletion, deactivation, and reactivation were added to the change memo in error over the summer. The new form is to be used for those options for the remainder of this year. At the April meeting, the change memo will be revised for next year to remove the options of program deletion, deactivation, and reactivation.

A new program, BS Chemistry, Biochemistry Concentration was approved. Policy requires concentrations within a major to have the same core. The BS, Chemistry program sheet does have the same courses as the Biochemistry concentration but they are not grouped the same way. Approval of the new concentration was subject to the existing B.S., Chemistry program sheet

being reformatted so that the core matches the Biochemistry concentration. The changes to the B.S., Chemistry program sheet will be verified by the Chair rather than going through the entire approval process.

December 11, 2014

The committee decided that the procedure for voting on the subcommittee's minutes will be to vote at the first meeting in which the minutes appear on the agenda.

The committee approved the Essential Learning Committee minutes from 11/12/14 and 11/19/14.

The committee decided that a text box for Essential Learning outcomes will be added to the course addition and course modification forms.

January 22, 2015

The committee was asked to take a moment to remember Regis Tucci and his many contributions to the curriculum committee.

A new "Proposal to Modify Program Based on the Essential Learning Curriculum" form will be used by departments to document the changes to the program sheets related to the addition of the Maverick Milestone and Essential Speech courses. These forms will be completed by the department head and the curriculum committee representative, and will only be in use for the March and April meetings.

Don Carpenter announced that Faculty Senate is working on a replacement for the course description evaluator position formerly held by Regis Tucci. The Chair and Vice-Chair will ensure that all new course descriptions are reviewed by the end of the semester.

The following changes to Curriculum Policies and Procedures Manual were approved:

• Pg. 6- approval sequence

The change on pg. 6 is in section II.A.2. The need for the change is to allow the approval sequence to indicate that Financial Aid only needs to review new program proposals, rather than new program and new course proposals.

One "*" will now designate "for creation of programs" instead of "for creation of programs and courses." Two "**" will designate "for creation of programs and courses" instead of "for creation and modification of courses." Three "***" will now designate "for creation and modification of courses" instead of "for creation of new academic programs and other substantive changes." Four "****" will now designate "for creation of new academic programs and other substantive changes" instead of "for majors only." Five "*****" will designate "for majors only."

Based on the new one - five asterisk key, the following lines of the approval sequence are being modified:

- o "Essentential Learning Committee**" changed to "Essential Learning Committee*** (typo corrected as well)
- o "Library*" changes to "Library**"
- o "Course Description Evaluator**" changes to "course description evaluator**"
- o "Colorado Mesa University Board of Trustees***" changes to "Colorado Mesa University Board of Trustees***"
- o "Colorado Department of Higher Education****" changes to "Colorado Department of Higher Education****"
- Pg.7- deadline to submit proposals is corrected to read three weeks instead of two.

The change to pg. 7 is section II.C.1. The section currently states "By Noon two weeks prior to the meeting, curriculum proposals and other agenda items must be received by ..." As a review of the UCC dates and deadlines for prior years shows, the calendar has allowed for three weeks between the proposal submission deadline and committee meeting. This section will now read "By Noon three weeks prior to the meeting..." so that the policy matches the established practice.

• It was discovered that the Curriculum Policies and Procedures Manual states "Course Description Evaluator" instead of "Catalog Description Evaluator." This will be updated five times in sections: I. F. Meeting Dates, Time, Agendas and Minutes, #4.a (pg. 5); II.A.2 Approval Sequence (pg. 7); II. B. C. Deadlines for Submission of Proposals, #5 (pg. 8); and III.B. Catalog Description, #1 (pg. 13) [occurs two times].

February 26, 2015

Susan Longest was announced as the new Catalog Description Evaluator.

Work sessions to review the Essential Learning modifications to program sheets have been scheduled.

March 12, 2015

It was clarified that most AAS programs will not have extensive changes related to the Essential Learning modifications, but that an EL modification form should still be submitted. None of the options on the form apply to most AAS, so it should be filled out as "not applicable."

April 9, 2015

Chair Chapin and Vice-Chair Hawkins were elected to continue in their respective positions for the next academic year.

The committee discussed possible changes to be made to the curricular change forms for next year, including suggestions from the Registrar's Office.

UCC and WCCC sections of the Annual Report will be prepared over the summer and approved at the first meeting of Fall 2015.

The committee approved changes to Curriculum Policies and Procedures Manual related to changing "General Education" to "Essential Learning."

The committee approved the 2015-16 UCC Dates and Deadlines.

The committee briefly discussed the five Program Reviews for 2014-15: Computer Information Systems; Construction Management; Mathematics; Psychology; Spanish; and Visual Communications. Chair Chapin informed the committee that she and Vice-Chair Hawkins had reviewed the curriculum section of all five of the program reviews and did not identify any potential curriculum issues or any curriculum deficiencies.
