Information and Business Items

August 27, 2015 Meeting

Officer Elections

Vice-Chair Hawkins explained that the previous chair of the committee, Tonya Chapin, resigned from the University over the summer. Hawkins opened the floor for nominations:

Nominations for position of chair: Jeremy Hawkins (**LaBombard-Daniels/Hancock**). There were no further nominations. Hawkins turned voting over to committee member Atkinson to complete the elections for chair. **Hawkins was unanimously elected as chair.**

Nominations for position of vice-chair: Scott Kessler (**Hawkins/LaBombard-Daniels**). There were no further nominations. **Kessler was unanimously elected as vice-chair.**

Proposal Review Process

Hawkins explained proposed changes to the proposal review process that have resulted from conversation with academic staff over the summer. The current subgroup review process is time intensive, seems to detract from the crucial charges of the committee, and results in the resubmission of many proposals. In the proposed process, the subgroup review structure would be replaced by a buddy system in which newer committee members are paired with returning committee members as “buddy reviewers” to look at proposals prior to the initial submission. Buddy reviewers will receive the proposal one week prior to the submission deadline (existing due date for library and catalog description review). The executive subcommittee meetings that predated the subgroup structure would be reinstated to occur approximately one week after the main submission deadline for the chair, vice-chair and catalog description reviewer to meet to discuss proposals prior to setting the agenda. Any issues with the proposals as initially submitted by the departments will be investigated/resolved by the executive subcommittee and needed corrections will be made directly in the database. As much as possible, the resubmission of proposal forms will be avoided. There was discussion. It was clarified that the revised forms and increased reliance on the database should help to both condense the agenda and to allow for it to be sent to the committee at least one full week prior to the meeting, so it should be feasible for the entire committee to review the proposal packet for any items of particular interest to their respective departments. There was general support for the new approach. **Motion: to try new approach of the “buddy review” with the understanding that if it is successful the Manual will be revised to reflect the new process (Hancock/Atkinson); motion carried.**

Revised Dates and Deadlines for 2015-16 (distributed with agenda)

The dates and deadlines calendar have been revised to indicate that the reps will submit proposals to their assigned buddy reviewer one week before the main submission deadline [the same date that proposals are submitted to the library and catalog description reviewer as necessary]. The column for the approximate date that the proposals are sent out to the subgroups for review has been changed to the approximate date that the executive subcommittee will meet to discuss the proposals. **Motion: to approve the revised dates and deadlines for 2015-16 with corrections as noted above ((LaBombard-Daniels/Hancock).**

Approval of 14-15 Combined Curriculum Committee Annual Report

Haas stated that in the section of approved Essential Learning courses that it should be noted that SPCH 101 and 102 were previously in the Applied Studies Category. Jennings noted the following: remove the “Program change to “NA - NA” (pg. 32) notation under the BS Political Science entry and add the approval of the deactivation of the BAS in Public Admin/Public Safety that happened on the 2/26/15 meeting. **Motion: to approve the 14-15 Annual report with the corrections to the SBS and EL Committee sections as noted above (Longest/Jennings); motion carried.**

Curricular change forms for 2015-16

In order to be able to provide approved curriculum changes more quickly to the Registrar’s Office to update DegreeWorks and complete other processing tasks, the existing reporting capabilities of the curriculum database need to be more fully implemented.

It was not feasible to modify the previous Intra-departmental Change Memo so that it could be compatible with the database, so the Change Memo will not be in use any longer. The remaining forms were improved to help streamline the process. Changes to the forms included:

- Separate program modification and addition forms.
- Programming added so that all departments’ degrees and programs can be selected from a drop-down list and do not have to be typed in.
- Removing the effective dates as a field that the department completes, as effective term is determined by policy and approval sequence.
- Changes to the format of the course modification form so that only course characteristics that are changing need to be entered, as well as more complete instructions.
- Aligning all forms with the policy manual.
- Adding a field on the program deactivation/deletion form to help clarify that deactivating a program includes a required examination of the status of the program one year after the conclusion of the teach out plan.

Motion: to adopt the 2015-16 curricular change forms (Van Brussel/Ferreira-Lillo); motion carried.

September 24, 2015 Meeting

Hawkins asked for feedback from the committee on the new “buddy system.” Feedback was positive, although some members had not yet prepared proposals, so had not yet utilized the buddy review process.

October 22, 2015 Meeting

The upcoming proposal submission deadlines were discussed. No business or information items to note.

November 12, 2015 Meeting

The wording related to Essential Learning has been updated on the forms. Please download forms from the website.

December 10, 2015 Meeting

Chair Hawkins asked the committee to be prepared for longer meetings in January and February as it is expected the agendas will be long. There are only two remaining meetings this year in which to consider proposals to be implemented for AY 2016-2017.

Status of Deactivated Programs

- Re-examination feedback was sought from departments regarding the following programs:
 - EMT-- Paramedic – AAS and Technical Certificate; Deactivated April, 2013. Update requested from department by December, 2015. Acting VP for Community College Affairs Adkins stated that students have expressed interest in the two programs being re-activated, and at the request of President Foster she has been exploring how the EMT-Paramedic programs could be reconfigured and offered in a way to produce more graduates. The committee should expect to see a proposal to reactivate the program at the February 2016 meeting. It was noted that Health Sciences still offers the EMT Basic certificate. It was noted that after the AAS, Paramedic program was deactivated, it was also withdrawn from accreditation.
 - AAS, Construction Technology – Craft, and Technical Certificate, Construction Technology; Deactivated November, 2013. An update requested from WCCC by December, 2015.
- Departments were informed of upcoming re-examination review dates for recently deactivated programs:
 - BAS, Public Administration/Public Safety. Deactivated, February, 2015. Status report is due to this committee during Fall 2017.
 - Technical Certificate, Manufacturing Supervision. Deactivated, February, 2015. Status report is due to this committee during Fall 2016.

January 28, 2016 Meeting

Library Assessments Process

Chair Hawkins explained that there have been some issues with the timely completion of library assessments and asked Grossman to explain the process to the committee. Please remember to submit proposals to Grossman at least one week ahead of the main submission deadline. Proposals to add new programs and courses require a library assessment.

Status of Deactivated Programs

Reexamination feedback has still not been received from WCCC regarding the AAS, Construction Technology – Craft, and Technical Certificate; Deactivated November, 2013.

February 25, 2016 Meeting

Status of Deactivated Programs

Acting VP Adkins reported that a memo stating that the AAS, Construction Technology – Craft, and Technical Certificate, Construction Technology will remain deactivated is forthcoming.

March 10, 2016 Meeting

Upcoming revisions to policy manual and proposal forms

The committee was asked to review list of needed policies updates and identify additional items. The issues around SLOs for programs and courses are being addressed with Bette Schans, Director of Assessment of Student Learning. In addition, the committee was asked to provide suggestions for improvement to the proposal forms. The forms will remain online for review purposes until March 24 and then will be taken down in order to be revised for the 16-17 year.

Review of 2016-17 Program Reviews to identify any curricular concerns

There were no curricular issues raised by the committee upon review of the program reviews for the following programs:

- BS, Environmental Science and Technology
- Emergency Medical Services
- BBA and BAS, Business Administration
- AAS, Tech Cert - Culinary Arts; and AAS, Baking and Pastry
- BA, Mass Communication

Motion: To acknowledge that the committee has reviewed the curricular aspects of the program reviews listed above (Hancock/Gurka). Motion Carried.

Status of Deactivated Programs

The committee acknowledged a memo from WCCC requesting continued deactivation status for the AAS, Construction Technology – Craft, and Technical Certificate, Construction Technology. As these programs were deactivated in November, 2013, they must be either deleted or reactivated by November, 2017.

April 14, 2016 Meeting

Announcements

- Curriculum change forms for 16-17 will be posted online by approx. July 1, 2016.
- The next meeting will be August 25, 2016. The UCC section of 2015-16 Annual Combined Curriculum Report will be approved next fall but a draft will be sent for review in May.
- Rose Petralia, Head of Library Public Services would be taking over for Jeff Grossman as the library representative next year.

Essential Learning Subcommittee Minutes

Chair Hawkins noted that the EL minutes noted the approval of MUSA 267 as an addition to the Fine Arts Category, and that this committee has already approved that as well. **Motion: to approve the EL Subcommittee 2/11/16 minutes (Lombard/Daniels); motion carried.**

2016-17 Curriculum Proposal Deadlines and Meeting Calendar

The proposed calendar was discussed. A deadline for materials submitted to the Director of Assessment of Student Learning (DASL) was added to the same step as submission of materials for library assessment, course description evaluations, and financial aid approval.

There was discussion regarding the unbalanced committee work flow throughout the year, with some fall semester meetings taking only a few minutes with an unreasonably long meeting in February. The high volume of proposals, including many program additions, in the February meeting could have been a factor in some issues with two program sheets not being identified in this year's February meeting. It was noted that the existing policy allows for any meeting agenda to be completed the following week, a note that has been added to the 2016-17 calendar. Chair Hawkins noted that extending deadlines until March would not allow time for changes to be reflected in the fall course schedule. After further discussion, it was decided to propose a new policy in which program additions to be reviewed by the UCC must be submitted by the deadline for the January meeting. Program modifications and other changes will still have the deadline of the February meeting to be considered in time for catalog inclusion. **Motion: to approve the proposed calendar with the change of moving the deadline for submission of program addition proposals to align with deadlines for the January meeting instead of the February meeting (Longest/Gurka). Motion carried.**

Combined Curriculum Policy and Procedures Manual Revisions

Chair Hawkins explained the proposed revision. See the marked up Manual for details. It was noted that the proposed revisions were sent to Don Carpenter, Chair of the Graduate Curriculum, for input as well. **Motion to approve the proposed revision to the Combined Curriculum Policy and Procedures Manual, making the adjustments noted during the meeting. (Longest/Quinn-Hensley); motion carried.**

Through the review of the Manual, Chair Hawkins found a few issues for clarification that might fall under the Academic Policies Committee rather than this committee. **Motion: to ask the Faculty Senate to consider seeking clarification through the Academic Policy committee on the following, if not already undertaken: (Hawkins); Motion carried.**

- 1) The current policy language specifies that "It is required that a minor, if selected, be outside the major so as to encourage a secondary focus to broaden the scope of the educational experience." Yet, item E.2. states that "double counting of courses" is allowed, in particular when "the completion of a minor may include: course requirements specific to a major." Request that Academic Policy reviews the amount of course overlap allowable between a major and a minor. Suggest that there be no more than 33% overlap.
- 2) Clarification of requirements for Professional Certificates. Add requirements for Academic Residency (see page 57 of the catalog wherein residency requirements are listed for technical certificates but not professional certificates) and clarify that professional certificates may

require pre-requisite course work to be completed prior to beginning the course work for the certificate.

Returning Members for 2016-17

Monte Atkinson (Music), Carolyn Ferreira-Lillo (WCCC), Carolyn Quinn-Hensley (Art and Design) and Jeremy Hawkins (Kinesiology) will not be returning to the committee next year. Keith Fritz will finish the remaining year of Jeremy Hawkins' term. Other new members are unknown at this time. Departments should coordinate with Faculty Senate to find replacements.

Election of 2016-17 Officers

As Chair Hawkins will not be returning to the committee next year, he opened nominations for the position of the 2016-17 Chair. No nominations were made. The election of the Chair will need to occur at the first meeting of Fall 2016.

Motion: to nominate Scott Kessler to continue as Vice-Chair. (Hawkins/Quinn-Hensley). No other nominations were received. Motion carried. It was noted that in the absence of an elected committee chair, it will fall to the Vice-Chair to convene the first meeting of Fall 2016 and preside over the election of chair at that meeting.

May 2, 2016 - Report of Executive Subcommittee Action

Executive Subcommittee members Jeremy Hawkins, Scott Kessler, and Susan Longest voted unanimously via email to approve further modification to the following program sheets, originally approved at the 2/25/16 UCC meeting.
