

## **2026-2027 Financial Aid Terms and Conditions**

The following terms and conditions explain the requirements for receiving financial aid at Colorado Mesa University/CMU Tech ("CMU"). By accepting any portion of your financial aid offer, you acknowledge that you have read, understand, and agree to the terms below. Throughout this document, "I," "me," and "my" refer to you, the student.

### **1. General Financial Aid Eligibility Requirements**

- To receive federal financial aid at Colorado Mesa University / CMU Tech (CMU), I must meet general federal student eligibility requirements, including but not limited to:
  - Be a United States citizen or eligible noncitizen as defined by federal regulation
  - Have a valid Social Security number, if required by federal regulation
  - Have a high school diploma, recognized equivalent, or have completed an approved home school program
  - Be admitted and enrolled as a regular student in an eligible degree or certificate program at CMU
  - Not be in default on a federal student or parent loan and not owe a repayment on a federal grant or loan
  - Meet Selective Service registration requirements, if applicable
  - Maintain Satisfactory Academic Progress as defined by CMU
- I understand that if I fail to meet any of these requirements, I may lose eligibility for federal financial aid until I correct the issue, and federal eligibility is restored.
- To receive Colorado state-funded financial aid at Colorado Mesa University / CMU Tech (CMU), I must meet general state eligibility requirements, including but not limited to:
  - Meeting Colorado residency or ASSET criteria for in-state tuition and state aid as defined by Colorado law and CMU residency policy
  - Being admitted and enrolled as a regular student in an eligible degree or certificate program at CMU
  - Meeting Satisfactory Academic Progress standards as defined by CMU
  - Not being in default on a federal or state student loan and not owing a grant or loan overpayment to any institution or program
  - Submitting all required state or institutional applications and documentation by published deadlines
- I understand that Colorado state financial aid is generally reserved for students who qualify for in-state tuition status under Colorado law, including students who qualify under Colorado ASSET provisions.
- For ASSET students, I understand that Colorado law allows certain students who do not have lawful immigration status but who have resided and attended high school in Colorado to qualify for in-state tuition and state aid if they meet specific high school attendance, graduation or GED, residency, and affidavit requirements. CMU applies these requirements as outlined in its residency policy and Colorado Department of Higher Education guidance.
- I understand that the Colorado Application for State Financial Aid (CASFA) is used to determine eligibility for Colorado state financial aid and some institutional aid when I am not eligible to complete the Free Application for Federal Student Aid (FAFSA), including:
  - Undocumented students, including many ASSET students
  - Certain noncitizen or nonresident students who are not eligible for federal Title IV aid
- I understand that:
  - If I am eligible to complete the FAFSA and receive federal Title IV aid, I should not complete the CASFA; federal and state aid will be determined based on my FAFSA.

- If I am not eligible for federal aid, I may complete the CASFA to be considered for Colorado state grants, state-funded work-study, and certain institutional aid at CMU, subject to available funding and program-specific requirements.
- I understand that specific Colorado state aid programs may have additional eligibility criteria, which can include:
  - Enrollment at least half time in an eligible program
  - Not having previously earned a bachelor's degree when receiving certain undergraduate state grants
  - Demonstrating financial need as determined by information reported on the FAFSA or CASFA
  - Meeting any program-specific conditions that apply to state-funded scholarships or work-study
- I understand that Colorado state aid is subject to annual appropriations by the State of Colorado and to Colorado Department of Higher Education and CMU policies. My eligibility and award amounts may change from year to year based on state funding levels, changes in law or policy, and changes in my residency classification, immigration status, financial circumstances, or enrollment.
- I agree that it is my responsibility to review CMU's residency information, state financial aid information, and CASFA guidance, and to provide any documentation required to establish or maintain eligibility for Colorado state financial aid.

## **2. Use of Financial Aid & Authorization to Apply Aid**

- I agree to use all federal, state, and institutional financial aid solely for educational expenses incurred at Colorado Mesa University / CMU Tech (CMU), as permitted under applicable federal and state regulations.
- By accepting these terms and conditions, I authorize CMU to apply my financial aid to any allowable institutional charges on my student account, consistent with the [Financial Responsibility Agreement](#) I sign prior to registration. Allowable institutional charges generally include tuition, mandatory fees, and approved housing and meal plan charges.
- I authorize CMU to apply my federal financial aid to non-institutional charges on my account, such as parking fines, library fines, and late fees, unless I revoke this authorization in writing.
- I authorize CMU to apply up to two hundred dollars of my federal financial aid to allowable prior-year charges, as permitted under federal regulation.
- I understand that CMU may review, adjust, or cancel my financial aid at any time if there are changes in my eligibility, enrollment, residency classification, financial circumstances, or the availability of funds.
- I understand that any additional financial resources I receive from outside CMU, including but not limited to scholarships, waivers, tuition assistance, or third-party payments, may reduce my financial aid and may require repayment of previously disbursed funds.
- I understand that aid received at another institution may affect my eligibility at CMU as described in the 'Cost of Attendance, Award Limits, and Coordination with Other Aid' section.

## **3. Eligibility and Award Determination**

- I agree to comply with all federal, state, and institutional financial aid policies, including CMU's [Satisfactory Academic Progress \(SAP\) policy](#) and federal rules on official and unofficial withdrawals.
- CMU determines my eligibility for federal, state, and institutional financial aid using information from the Free Application for Federal Student Aid (FAFSA). For Colorado ASSET students, CMU determines state and institutional aid eligibility using information from the Colorado Application for State Financial Aid (CASFA). A federal processor uses my FAFSA information to calculate eligibility and sends the results to CMU.
- My eligibility for need-based aid is determined by the financial information I provide on the FAFSA or CASFA, and by federal, state, and institutional regulations. My aid may be adjusted or canceled if errors, omissions, or conflicting information are discovered at any time.

- Financial aid offers are created based on my eligibility, the availability of federal, state, and institutional funds, and applicable laws and policies. My financial aid package may include a combination of grants, scholarships, loans, and work-study.
- Financial aid eligibility is determined only after I have submitted all required application materials and documentation. Incomplete files will not be processed, and aid will not be disbursed until all requirements are met.
- All financial aid is contingent upon my continued eligibility and the accuracy of all information I provide. I am responsible for ensuring that all documents and information I submit to the CMU Financial Aid Office are true, accurate, and complete.
- I must resolve any federal aid holds, defaults, or overpayments before my financial aid can be disbursed. If I am in default on a federal student or parent loan, or owe a federal overpayment, I understand that I am not eligible to receive additional aid until federal eligibility is regained.
- I understand that CMU may access my federal aid history through the U.S. Department of Education to determine my aid eligibility.

#### **4. Verification, Professional Judgment & Additional Documentation**

- If I am selected for verification or if CMU identifies conflicting information, I must submit all requested documentation. My financial aid will not disburse until verification or review is complete. If discrepancies are found, my eligibility and awards will be recalculated and may be reduced or canceled, and I may be responsible for repaying funds already disbursed.
- I may request a review of my financial aid application if I experience significant changes in my financial situation or personal circumstances. These requests will be evaluated individually, may require supporting documentation, and may not result in changes to my financial aid.

#### **5. Federal Student Loans, Reporting, and Exit Counseling**

- If I choose to borrow federal student loans, I understand that:
  - I must complete required federal entrance counseling and sign a Master Promissory Note before loan funds can be disbursed.
  - Federal student loan funds are borrowed money that must be repaid, with interest, according to the terms of the Master Promissory Note and federal regulations.
  - My federal student loans will be reported to the National Student Loan Data System and may be accessed by authorized federal agencies, loan servicers, and institutions.
  - I can review my federal loan and grant history and access information about my loan servicer through U.S. Department of Education resources.
- If I graduate, withdraw, or drop below half-time enrollment and have received federal student loans, I must complete required federal exit counseling. CMU will notify me of this requirement and provide instructions.
- I understand that I am responsible for knowing and complying with all terms and conditions of my federal loans as outlined in the Master Promissory Note and federal counseling materials. Failure to make payments when due may result in default, additional fees and costs, damage to my credit, and other federal collection actions.
- By accepting federal loans, I am aware that loan fees will be charged to originate my student loan and are calculated as a percentage of the total loan amount. These loan fees are deducted from each loan disbursement and will be subtracted directly from the loan before it is disbursed to my student account.
- I understand that starting in the 2026-2027 academic year, federal student loans will be adjusted based on annualized enrollment. Any enrollment less than full-time for the year (12 credit hours fall semester + 12 credit hours spring semester) will be prorated resulting in reduced loan eligibility.

#### **6. Cost of Attendance, Award Limits, and Coordination with Other Aid**

- An estimated Cost of Attendance (COA) is used when determining my financial aid eligibility and packaging. The COA includes tuition, fees, course materials, housing, food, personal expenses, and transportation. COA budgets are built to reflect full-time enrollment for each program level and my living arrangements as defined by institutional policy.
- I understand that my financial aid offer cannot exceed my COA, and that my COA does not represent the exact amount I will owe to CMU. I am not guaranteed to receive financial aid sufficient to meet my entire COA or to cover all of my educational expenses.
- My financial aid offer is developed based on full-time enrollment. If I enroll less than full time, my aid will be reviewed and adjusted as required by federal, state, and institutional rules.
- My financial aid offer is subject to change due to changes in my financial status, academic status, enrollment status, residency classification, or changes in the availability of funds.
- Between the time campus charges are assessed and the semester census date, my COA may be adjusted to reflect my actual tuition, fee, and on-campus housing and meal plan costs.
- I understand that federal annual and aggregate limits apply to certain aid programs, including Federal Pell Grants and Federal Direct Loans. These limits may affect the amount of aid I can receive in a given year and over my lifetime.
- I understand that I may not receive aid from more than one school for the same term. If I enroll at more than one institution, I may be required to complete a consortium agreement to determine which school will process my aid for that term. Aid I receive at other institutions may impact my eligibility at CMU.

## **7. Enrollment, Academic Engagement, and Satisfactory Academic Progress**

- I understand that eligibility for financial aid requires that I be enrolled as a regular student in an eligible degree or certificate program at CMU. Financial aid will only pay for coursework that applies toward my declared program of study, subject to federal repeat coursework regulations.
- My financial aid is initially offered assuming full-time enrollment. If I enroll less than full time, or change my enrollment after aid is awarded, my aid may be adjusted or canceled as required by federal, state, or institutional rules, and I will be responsible for paying any resulting balance owed to CMU.
- Federal Pell Grants are offered at the full-time enrollment level and will be prorated if I enroll less than full time, based on the number of credits in which I am enrolled and that are eligible for Pell funding.
- Colorado State Grant, Federal Supplemental Educational Opportunity Grant (SEOG), Federal or Colorado Work-Study, and most CMU scholarships require full-time enrollment. If I enroll less than full time, I understand I may not be eligible to receive these funds.
- I understand that my financial aid will normally be split evenly between fall and spring semesters unless otherwise specified. If I plan to attend the summer term, I must follow CMU's summer aid application process so that any remaining eligibility can be applied.
- Academic engagement is required to earn financial aid. If I do not attend or engage in my courses, I am not entitled to keep my aid. If I am unable to engage in any course for any reason, it is my responsibility to drop or withdraw according to CMU procedures, and I may be required to repay all or a portion of my financial aid.
- I understand that audited courses do not count toward enrollment for financial aid purposes. Federal aid may only be used to pay for one repeat of previously passed coursework, as defined by federal regulation.
- I understand that changes in my enrollment or academic status may affect my financial aid and may create a balance owed to CMU. These changes include, but are not limited to:
  - Non-attendance or failure to begin a course
  - Dropping or withdrawing from courses
  - Registering for ineligible coursework that does not apply to my program
  - Receiving incomplete grades

- Changes in program of study or residency classification
- CMU's SAP policy requires that I:
- Maintain at least the minimum institutional cumulative GPA specified in the SAP policy based on the number of completed credits
- Successfully complete at least sixty-seven percent of all institutional credits I attempt (pace of progression)
- Complete my program within one hundred fifty percent of the published length of that program

- If I fail to meet SAP standards, I understand that I will lose financial aid eligibility unless I successfully appeal and am placed on financial aid probation, or regain eligibility as outlined in [CMU's SAP policy](#). The semester census date is the official date each term at which my enrollment is locked for financial aid eligibility and SAP evaluation purposes.

## 8. Withdrawal, Failing All Courses, and Return of Title IV Funds

[CMU's Return to Title IV policy](#) follows the federally required actions should a student complete a semester withdraw or fails all courses.

- I understand that if I receive a financial aid disbursement and do not attend any of my classes at CMU, federal regulations require that all of my aid be canceled and returned. In that case, I will be responsible for paying all resulting charges on my CMU account.
- If I officially withdraw from CMU or cease attendance in all courses during a term, federal law requires CMU to perform a Return of Title IV (R2T4) calculation to determine the amount of federal aid I earned based on my last date of attendance.
- If the R2T4 calculation shows that I received more federal aid than I earned at the time I withdrew, the unearned portion must be returned to the federal programs. I am responsible for repaying any unearned aid and for paying any resulting balance owed to CMU in full before I can re-enroll or receive additional transcripts or services.
- If I fail all courses in a term, CMU is required to determine whether I unofficially withdrew. I may be required to provide documentation of my last date of attendance or academic engagement. If I cannot provide documentation, CMU will perform an R2T4 calculation using the fifty percent point of the term as my last date of attendance, which may result in repayment obligations.
- If I am eligible for a post-withdrawal disbursement of federal aid after I withdraw, I will be notified. I must accept or decline the funds within the timeframe specified in the notification. If I do not respond by the deadline, CMU may not be able to disburse those funds.
- Institutional and state [refund policies](#) may differ from federal R2T4 calculations. I understand that institutional charges, late fees, and other non-refundable items may remain due even if a portion of my federal aid is returned.

## 9. Payment of Aid Process

- Financial aid awarded in the form of grants, scholarships, and loans will be applied toward my student bill first and will pay outstanding tuition, fees, and authorized charges I owe to CMU.

- I understand that the earliest funds will disburse each term as follows:
  - The majority of CMU aid will be disbursed to my CMU student account 10 days before each term
  - Aid that requires enrollment verification will disburse after CMU's census date each term
- If I am scheduled to receive more financial aid (not including work-study) greater than the balance I owe to CMU, I understand I may be issued a refund.
- If eligible for a refund, I understand it will be issued through direct deposit or a paper refund depending on my preference. Electronic refunds will be sent to the bank account I specify in the ePay app. Physical paper checks will be mailed to the permanent address on file with CMU. It is my responsibility to ensure that my address is valid.

## **10. Federal and State Work-Study Employment Conditions**

If I receive Federal or Colorado Work-Study, I understand that:

- Work-study is an employment program; funds are earned through work and are not automatically applied to my student account.
- I must secure and maintain an approved work-study job through CMU in order to earn the amount listed in my aid offer. The listed amount is not guaranteed and depends on hours worked and available funds.
- I will be paid at least the applicable minimum wage and will receive earnings as wages, typically through CMU payroll on a regular schedule, subject to federal and state income tax withholding.
- Continued employment in a work-study position depends on my job performance, adherence to workplace rules, and continued financial aid and eligibility.
- If I fail to meet enrollment, SAP, or other financial aid eligibility requirements, or if funds are reduced or exhausted, my work-study eligibility may be reduced or canceled.

## **11. Student Responsibilities and Communication**

- I am responsible for officially dropping my courses and/or declining my financial aid if I decide not to attend CMU. Failure to do so may result in charges owed to CMU and federal or state programs.
- I will promptly notify the Registrar's Office of any change in my name, address, phone number, or program of study, and I will follow CMU procedures for updating my information.
- I understand that CMU email is the official method of communication for financial aid and billing matters. I am responsible for reading all messages sent to my CMU student email account and for responding or taking action when required.
- I am responsible for regularly reviewing my student account, financial aid status, and related messages in CMU systems, and for resolving any holds, missing documents, or outstanding balances by published deadlines.
- I understand that failing to read or respond to CMU communications does not excuse me from deadlines, requirements, or resulting charges.

## **12. Release and Use of Federal Tax Information (FTI) and Other Data**

- Data obtained by CMU through the Free Application for Federal Student Aid (FAFSA), including Federal Tax Information (FTI), is used for the application, award, and administration of financial aid in accordance with federal and state law.
- I understand that my personal information and FTI will be accessed and used only by authorized individuals with an official and legitimate need to know, for the sole purpose of determining my eligibility for and amount of federal, state, and institutional financial aid, and for related reporting and compliance activities.

- I understand that, in addition to agreeing to these terms and conditions, I may be required to submit written consent before CMU can disclose or discuss my FTI with other parties, including my parent(s), spouse, contributors listed on my FAFSA, or other third parties.
- I understand that CMU Financial Aid staff are not permitted to discuss another person's federal tax information, including the information of contributors on my FAFSA, with me unless that person has provided required written consent.
- I understand that CMU will safeguard my FTI and other sensitive information in accordance with federal, state, and institutional privacy and security requirements.

### **13. Student Rights Concerning Financial Aid**

In addition to the responsibilities described in these terms and conditions, I have important rights related to financial aid at CMU, including the right to:

- Know what financial aid programs are available at CMU, including federal, state, institutional, and private programs.
- Know the deadlines and procedures for applying for financial aid.
- Know how my cost of attendance is determined and what types of expenses are included.
- Know how my financial aid eligibility is determined and what criteria are used to select recipients and determine award amounts.
- Request an explanation of my financial aid offer and how it may change if my enrollment, residency, or other circumstances change.
- Review and request correction of information that CMU maintains about my financial aid record, consistent with FERPA and applicable privacy laws.
- Appeal a decision that affects my financial aid eligibility, including SAP determinations, according to CMU's published appeal processes.
- Request a review of my financial aid eligibility through professional judgment when I or my family experience significant changes in financial circumstances or other special circumstances.

### **14. Consumer Information and Additional Policies**

In addition to these Financial Aid Terms and Conditions, CMU is required by federal law to provide detailed consumer information to students. This information includes, but is not limited to:

- Procedures and forms for applying for financial aid
- Criteria for selecting financial aid recipients and determining award amounts
- Institutional refund policies and return of Title IV funds policies
- Satisfactory Academic Progress standards
- Academic programs, accreditation, and licensure information
- Campus safety, security, and crime statistics
- Student rights under the Family Educational Rights and Privacy Act and related privacy laws

I understand that this information is available on CMU's official website and in printed form upon request. I am responsible for reviewing these policies and procedures and for asking questions if I do not understand how they apply to me.

### **15. Fraud, Misrepresentation, and Accuracy of Information**

I certify that all information I provide to CMU and on my financial aid applications and supporting documents is true, complete, and accurate to the best of my knowledge.

I understand that:

- Providing false, misleading, or incomplete information in connection with my financial aid may result in the reduction, denial, or cancellation of aid.
- Suspected fraud or intentional misrepresentation may be referred to the appropriate federal, state, or institutional authorities for investigation and possible prosecution.
- I may be required to repay any aid for which I was not eligible as a result of inaccurate or fraudulent information.

I agree to promptly notify the CMU Financial Aid Office if I become aware of any errors or changes in the information I have provided.

## 16. Colorado Mesa University Merit Scholarship Recipients

Merit scholarship recipients must meet the following criteria to remain eligible for the scholarship and agree to the terms below for scholarship renewal.

- I understand that merit scholarships are awarded based on the criteria set forth by the CMU Admissions Office and the information I provided in my admission application and application materials to CMU.
- I understand that my merit scholarship is for undergraduate course work only leading to my first bachelor's degree or a maximum limit of 120 credits, whichever comes first. Credits include prior credits earned through AP/IB, concurrent coursework and/or transferred credits from another institution. Credits taken beyond the lifetime limit of 120 credits will not be paid for by this scholarship.
- I understand that I must enroll in at least 12 credit hours for each fall and spring semester. Any summer courses I choose to enroll in will not be paid for by my scholarship.

### *First Time Freshman Merit Renewal Criteria*

Renewable First-Time Freshman merit scholarships have the following conditions, and if these conditions are not met, I understand my eligibility for my original merit scholarship will be affected:

### *First-Time Freshman Annual Merit Assessment*

- I understand that at the end of each fall semester I will be assessed and notified by email of my current merit status.

- **Maintaining Merit** Student has met the requirements for maintaining their current level of merit scholarship.
- **Low GPA Merit Notice** Students not meeting the required Cumulative CMU GPA to maintain their current level of merit scholarship
- **Low GPA Warning** Student is not meeting the minimum required Cumulative GPA to maintain a merit scholarship
- **Max Credit Merit Warning** Student has reached 100 credits including prior credits earned through AP/IB, concurrent coursework and/or transferred credits from another institution.
- If placed on Low GPA or Max Credit Warning I understand the warning period will be for the following spring semester or the next term I attend.

#### *Annual GPA Merit Re-evaluation (Sliding Scale)*

- I understand that at the end of each spring semester my level of merit will be evaluated based on my Cumulative CMU GPA.
- The adjustment of my level of merit is subject to change each spring semester and I understand I may lose merit depending on my cumulative CMU GPA.
- If my cumulative CMU GPA falls below a 3.0, I understand that my scholarship will be cancelled without further notice, and I will be placed on Merit Suspension. Once on Merit GPA suspension, I could appeal the decision if I faced extenuating circumstances within the prior semester.
- If my merit suspension appeal is approved, I will be placed on Merit Probation and will be awarded at the level of Academic Achievement for the following term that I attend.
- If my merit suspension appeal is denied, I understand that the decision of the review committee is final, and my Merit Scholarship will be canceled.
- I will not be allowed more than two merit suspensions during my time at CMU.

#### *Merit Max Credit Evaluation*

- I understand that the semester I reach 120 credit hours including prior credits earned through AP/IB, concurrent course work and/or transferred credits from another institution; I will be placed on Merit Max Credit Suspension and my scholarship will be cancelled without further notice.
- Once on merit max credit suspension, I can appeal the decision.
- If my merit suspension appeal is approved, I will be granted an extension of my merit scholarship for no more than one academic year or until I complete my degree.
- If my merit suspension appeal is denied, I understand that the decision of the review committee is final, and my Merit Scholarship will be canceled.

#### *Other Admissions Scholarship Renewal Criteria*

Eligibility for other renewable Admission scholarships are evaluated each term and have the following conditions:

If these conditions are not met, I understand my eligibility for my original Admission scholarship will be affected, including the cancelation and/or suspension of the scholarship.

### **CMU Promise Residency**

To be eligible for the CMU Promise Tuition Program, I understand that state residency follows the same principles as the CRS 23-7-101, et seq. which governs tuition classification for in-state students and that CMU Promise status requires domicile in the state of Colorado for the year immediately preceding the first day of class or proof of membership to the Ute Tribes of the region (Southern Ute Tribe, Ute Mountain, or Uintah and Ouray).

### **17. CMU/CU Partnership**

The Engineering Partnership Program offers students the opportunity to earn a University of Colorado Boulder engineering degree in Civil, Electrical and Computer, or Mechanical Engineering entirely on the campus of CMU. The first two years are taught by Colorado Mesa University faculty; the last two years of engineering courses are taught by University of Colorado Boulder faculty in Grand Junction.

- As a participant in the CU/CMU Engineering Program I understand that while enrolled in lower division courses with CMU I will pay CMU tuition, am eligible for CMU financial aid and scholarships, and my financial aid will be disbursed by the CMU Financial Aid Office.
- Upon completion of my lower division courses, I understand that my program will transfer to the CU Boulder program requirements. I will be responsible for paying CU Boulder tuition and fees; financial aid will be disbursed by CU Boulder, and I may be eligible for CU Boulder scholarship opportunities.
- I understand that my CMU scholarships, Admissions Based Merit, Foundation, and/or athletic scholarships are not applicable once I have transferred to CU Boulder and will not be paid.
- It is my responsibility to contact the scholarship provider of any private scholarships received outside of CMU to ensure the funds are sent to the CU Boulder instead of CMU.
- If I have received the tuition classification from CMU of either the Western Undergraduate Exchange (WUE) or Mountains & Plains (M&P) as a student at CMU, I may be eligible for a scholarship from the University of Colorado Boulder that is equal to the difference between the out-of-state tuition rate and 150% of full-time in-state tuition. It is my responsibility to connect with CU staff to complete this process.
