



### **Clinical Expectations for the remaining S20 semester....**

The COVID 19 pandemic has generated challenges for students in clinicals this semester. Drs. Hall and Marshall have reviewed recent information from the National Organization of NP Faculty (NONPF), the American Association of Colleges of Nursing (AACN) and the Commission on Collegiate Nursing Education (CCNE) in guiding students on how to finish clinical hours this semester. The following is a guiding statement to assist with planning your remaining clinical course expectations. Your course progression sheet indicates where you are in clinic hours to date.

**Direct clinical hours for this semester will be met based on the following formula:**

***If a DNP FNP or MSN FNP or MSN NE student has met:***

- 1. < 50% of clinical hours for the course student will = take incomplete; attend tabletop exercise as incident command**
- 2. Between 50% to 100% student will:**
  - ***create SMART objectives on how to complete coursework prior to April 15<sup>th</sup>\****
  - ***attend tabletop exercise as an 'incident command' leader or attend as a team member***
- 3. 100% of clinical hours no need to make up clinical hours**

*\*Send SMART objectives to your faculty advisor*

Students in either the DNP FNP or the MSN FNP tracks are expected to have a minimum of 500 direct patient care clinical hours for certification eligibility. CMU graduate nursing program requires 700 hours of direct clinical care as a minimum.

Students in the MSN Nurse Educator track are expected to obtain *direct* clinical hours in three courses: NURS 577 Clinical Practicum: Advanced Health Assessment (1 credit), NURS 545L Curriculum Design/Evaluation Laboratory (1 credit) and in NURS 560 Nurse Educator Practicum (3 credits). Students in NURS 577 are expected to follow the above guideline in finishing their clinical hours for the semester. Contact your faculty advisor if you have questions.

### **Advising**

*Course progression sheets have been completed and will be sent to each student by 3/30/20. If you have questions, please contact your faculty advisor. Students who may need additional time for clinical will be counseled individually for them to plan registration. **OPEN sessions for advising will be on March 31<sup>st</sup> except from 1-230pm due to faculty meeting.***

### **Tabletop Exercises April 28th (indirect clinical hours).**

ALL NURS 577, 610, 630, & 652 students have the opportunity for indirect clinical hours by participating in disaster preparedness tabletop exercises. **Tabletop exercises will be offered on April 28<sup>th</sup>.** Each tabletop session will count as an additional **4 indirect clinical** hours if you are an "Incident Commander" and **2 hours** if you are a "team member" of that exercise. You are permitted and encouraged to participate in more than one tabletop exercise.
