The Moss Performing Arts Building was constructed in 1968 and is approximately 74,500 sf. Currently, the Performing Arts Building houses the University's Department of Theatre Arts and Music programs; the University anticipates the facility to be occupied during construction. The goal of the project is to address safety, accessibility and code compliancy all while addressing space utilization by increasing the capacity to accommodate additional students, staff and community members.
