## How to create a CITI account (for people new to CITI):

- Head to the <u>CITI</u> website
- Click Register
- Click Select Your Organization Affiliation
- Search for and select Colorado Mesa University from the dropdown menu
- Agree, affirm, and click Create a CITI Program Account
- Fill out the fields

## How to add an affiliation with Colorado Mesa University (for people who already have a CITI account):

- Log into <u>CITI</u>
- Under the welcome message on the left in the blue banner, click "Add Institutional Affiliation"
  OR
- Under the Institutional Courses introduction, click "Add an Affiliation" in the description
  OR
- Click on your name in the top right corner
- Click "Profiles" on the dropdown menu
- Under the Institutional Profiles section, click "Add an Affiliation"

#### THEN:

- Search for Colorado Mesa University and select when it appears on the dropdown menu
- Agree to the terms and affirm that you are affiliated with CMU

## How to add the IRB required Social/Behavioral course (for everyone):

- You should be automatically taken to the "Add a Course" enrollment questionnaire after completing your account set up or affiliation with CMU
- For Question #1, choose "Social & Behavioral Research Investigators" (see image below)
- Skip to the final question, #11, and select "No."
- Click "Submit"

- Scroll to the bottom of the page until you see "Learner Tools for Colorado Mesa University"
- Click on "Add a course"
- Answer question 1 of the enrollment questionnaire as applicable:
  - o e.g., "Biomedical Researchers" for Biomedical Researchers course or "Not at this time"
- Answer question 2 as applicable:
  - o e.g., "Social and Behavioral Responsible Conduct of Research Course" or skip the question
- Skip all questions that are not applicable. Question 1 is the only one that requires an answer.
- Submit

# <u>To REMOVE a course you don't need, such as the COVID-19 courses (Back to Campus, Remote Contract Tracing, etc.)</u>:

- Click on the blue "View Courses" button for Colorado Mesa University
- Scroll to the bottom of the page until you see "Learner Tools for Colorado Mesa University"
- Click on "Remove a course"
- Check the box for the course you want to delete from your account.
- **NOTE:** Only remove a course if you have not completed it and are not required to complete it. Removing a course after you have started or completed it <u>will delete all records of your work</u> in that course. Any module can be re-taken at any time to increase your quiz grade, so do not remove a course to re-do a quiz.

## To receive credit for your CITI training from another institution / check if it fulfills CMU's requirements:

- Follow the above instructions to ADD the course via the enrollment questionnaire
- Click on the blue "View Courses" button for Colorado Mesa University
- Find the course:
  - If it is under Completed Courses: all CMU required modules were fulfilled by your training at the other institution. Congratulations, you are certified here, too.
  - o If it is under **Active Courses**: some modules transferred over but not all of the CMU required modules were included in your other institution's version of the training. *If this is a required training*, such as the Social/Behavioral Research course, please complete the remaining modules to earn your certification for CMU.
  - If it is under Courses Ready to Begin: unfortunately, the CITI course for your other institution is not comparable to CMU's course so you must complete the full training to be certified at CMU.
    - <u>TIP:</u> Check the name of the course at your previous institution to see if you added the right one for CMU. For example, did you add the Social/Behavioral <u>Responsible Conduct of Research</u> course instead of the Social/Behavioral Research course?
