



Step 1: Admission

Apply. Complete the admissions application online at www.coloradomesa.edu/ - Click 'Apply Online' at bottom of page.

Request Final Transcripts/GED. Send official transcripts from high school and from each college attended or official GED scores. Official transcripts must be sent to WCCC for financial aid and graduation eligibility.

Step 2: Financial Aid and Scholarships

Step 3: College Opportunity Fund (COF)

Apply for the College Opportunity Fund Grant. The College Opportunity Fund (COF) was created by the Colorado Legislature to provide a stipend to eligible resident undergraduate students. The stipend pays a portion of your total in-state tuition when you attend a Colorado public institution. Eligible undergraduate students must be Colorado residents and may use the stipend for eligible undergraduate classes. Step 4: WIOA Funding Assistance

Apply for Workforce Investment Opportunity Act (WIOA) program. WIOA is a federal grant program that offers financial assistance for training for career fields in demand in the local labor market, as well as job search assistance to eligible individuals. WIA can help you prepare for employment, find and keep a job, and increase your earnings.

Step 5: Housing
